- Arrive At The Location Specified In The Contract on time
- Immediately Inform The Service Providers About The Problems Of Providing Quality Service.
- Provide Another Professional Service Provider If The F&S Professional Cannot Attend In Person
- Returns The Deposit In Case Of Termination Of The Contract Within a Month From The Moment Of Termination Of The Contract
- F&S Professionals Reserve The Right Not To Return The Deposit If The Contract Is Terminated By The Parties.
